- (ii) Professional experience not less than 4 years in the High Court or District Court for empanelment in the District Courts
- (iii) Having good communication skills and good knowledge of law and procedure.

Mode of Selection

1. The mode of selection will be interaction by selection committee.
2. In case a number of applications are received, short-listing of applications may be done. The department reserves the right to decide the criteria of short-listing.
3. Candidates so short-listed will then be called for interaction. Intimation will be sent at the correspondence address as given in the application form or/and over the telephone number given by the applicant.
4. Candidates will have to produce all original documents at the time of interview / interaction.

The Principal Secretary (Law), Govt. of NCT of Delhi reserves the right to accept or reject any application without assigning any reason. The application submitted will not bind this department to consider him/her for selection.
